OpenAIRE2020's goal is to implement European Commission Open Access policies and increase their impact by extending the infrastructure that will make it possible to manage and monitor EC-funded research.

LIBER's Role

LIBER leads the FP7 Post-Grant Open Access Pilot, aiming to distribute a €4 million budget for funding Open Access publishing fees for publications arising from FP7 projects across Europe.

Remote access to online resources is a strong requirement from academic users. They should be able to login with their existing institutional credentials. 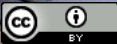

Scene Setter:

The resilience and cohesion of European societies are strongly conditioned by beliefs and identities, as well as by collective representations and constructions of past and present realities and expectations about the future. Research in the humanities and social sciences is well-placed for making important contributions to creating a new narrative for Europe by studying the drivers of and obstacles to the emergence of a European public sphere and a European cultural space. The role that technology can play in promoting a better understanding of the richness of Europe's heritage and diversity equally deserves further exploration as well as solutions-driven options.

A thorough and continuous reflection of Europe's cultural and social diversity and its past facilitates tackling societal challenges that European societies face today and will face tomorrow due to endogenous as well as external factors.

Understanding Europe is therefore a sine qua non condition for preparing and shaping the future, thus fostering truly reflective societies in Europe. A better understanding of Europe's cultural, social unity and diversity of its past will inform the reflection about present challenges/opportunities and help to find solutions for shaping Europe's future. Special attention should be dedicated to the accessibility for all and universal design in relation to the role that technology can play in promoting this better understanding.

This call has a link with the CO-CREATION call and with the cultural heritage related Topics of Societal Challenge 5 and other relevant parts of H2020.

In the Topic 12 on the significance of cultural and core values for the migration challenge, the participation of entities from the international partner countries and regions concerned is strongly encouraged.

The EUDAT2020 business plan will draw together results from other tasks within WP2 and from relevant activities across the project (notably tasks 3.2, 4.2 and 7.3). It will assemble the business case for the future CDI covering the following elements: (1) costs: drawing from cost modelling tools from the first EUDAT project, the pilots of tasks 2.4.2 and 2.4.3, and following guidelines and tools collected in particular by the 4C Project¹⁸, this task will explore common means to assess hardware, software and operational costs across the CDI; (2) funding sources: possible future funding sources for the European CDI will be appraised as realistically as possible, drawing on evidence from data storage and digital preservation activities elsewhere; (3) business models: the future CDI will be assessed as a layered business, treating data storage and management, access services, data curation services as separate but connected business offerings.

Deliverables

D2.1 Service Portfolio Processes Definition and SLA Template Set (M6) describes the new processes for maintenance and management of the CDI Service Portfolio, including templates for CDI Service Definition, Service Level Agreements and the overall Service Catalogue.

D2.2 Data Management Plan (M6) explains data management strategy within the CDI and EUDAT's support to the Open Research Data Pilot. This deliverable will evolve during the lifetime of the project.

D2.3 Certification Strategic Plan (M9) describes the planned steps for rolling out (preparation for) DSA

EU Projects Expectations

- You get 25% overhead over all costs -but it does mean you do have to report a lot!
- You can get a financial audit (5% randomly picked)
- If you are joining a consortium in submitting a proposal, you commit yourself to doing the work as described in the Description of Action

But... compared to earlier programmes (FP7) this H2020 programme is simplified in many ways:

- Single set of rules for all projects
- 100% funding rate
- 25% flat rate for overhead
- Simplified reporting process



EU Projects Benefits

- Great opportunity for cross border cooperation
- Get to know your peers, but also others
- You get funding for things you find are important for your institution
 - Funding for people working on the project
 - Funding for travel
 - Funding for other direct costs like posters and videos

Abstract:

This report focuses on personal data as an important, category of restricted data, and looks in particular at the legal requirements, both current and future, on EUDAT service providers storing and processing personal data. Guidelines and recommendations for EUDAT service providers are made on the basis of the newly-agreed EU General Data Protection Regulation (GDPR). A second version of this report will extend guidelines to cover broader categories of restricted data.

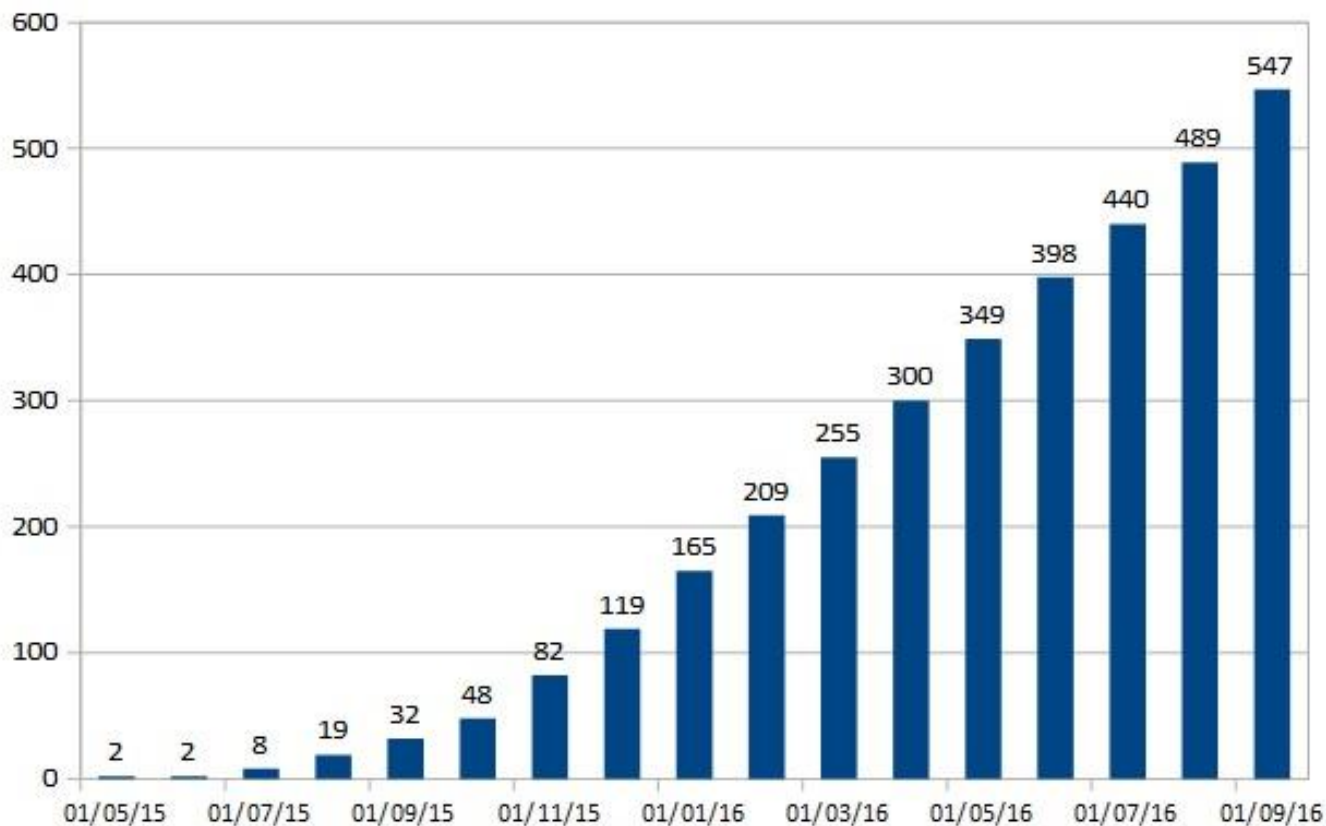
